

QuickBooks Accounting Integration Worksheet

The purpose of this worksheet is to streamline the integration between Focus POS and QuickBooks. Upon receipt of this worksheet, Focus programmers will link transaction triggers within Focus to their corresponding general ledger accounts in QuickBooks.

Process

Enter the corresponding QuickBooks General Ledger Account for each transaction trigger. You can use the same GL Account for multiple triggers if desired.
